If you have other family members on the Plan , each family member must meet their own individual Deductible until the total amount of Deductible expenses paid by all family members meets the overall family Deductible . |
| Are there services covered before you meet your Deductible ? | Yes. Pharmacy, hospice care, immunizations and Preventive Care are covered before you meet your Deductible . | This Plan covers some items and services even if you haven't yet met the Deductible amount.
