What is the overall <a href="Deductible">Deductible</a> ?	\$500 person/\$1,400 family	Generally, you must pay all of the costs from <u>Providers</u> up to the <u>Deductible</u> amount before this <u>Plan</u> begins to pay. If you have other family members on the <u>Plan</u> , each family member must meet their own individual <u>Deductible</u> until the total amount of <u>Deductible</u> expenses paid by all family members meets the overall family <u>Deductible</u> .
Are there services covered before you meet your <a href="Deductible">Deductible</a> ?	Yes. Pharmacy, hospice care, immunizations and Preventive Care are covered before you meet your <u>Deductible</u> .
